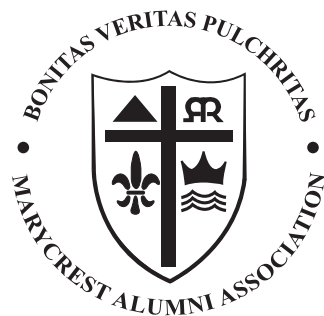

I'm a 1984 graduate of Marycrest College and worked on the campus until it closed in 2002. Now I work at the Marycrest Senior Campus for Petersen Commons Assisted Living. I am the Activity Coordinator and I love being back on campus!

When I first stepped on the Marycrest campus in 1980, I felt like it was home. It became home for so many of us through the years. And it continues to be home for some very special people. The property is now called Marycrest Senior Campus. Our campus has been converted into a spacious senior living residence.

To date, we have a total of approximately 160 apartments on campus. Rohlman Hall, Lawlor Hall, and Walsh Hall have been made into affordable housing for seniors; West Hall and Upham Hall are market rate apartments for seniors. Petersen Hall is now Petersen Commons Assisted Living, with 51 affordable housing apartments.

The Cone Library and the Nursing Building are still under construction. The library will eventually have four apartments in the lower level, and a Community Center with a large kitchen on the main floor. The Nursing Building has recently been renamed Henderson Hall, in honor of Sr. Sabina Mary Henderson, Marycrest's second president. It will be home to 16 apartments, storage units, and the existing auditorium.

Petersen Mansion serves as the current community center for the residents, and houses the offices of many Signature Management employees. The Activity Center was recently sold to a coach from Assumption High School, where various athletic events are held. In addition to concerts for the residents, Upham Auditorium is home to the Classic Film Society, which presents classic films once a month for the residents and public to enjoy.

I think you would be proud of what our beloved school has trans-

formed into. Chris Ales, the owner of Signature Management, has done a fine job in taking care of our campus (we all know it's not ours, but it still feels like it!).

Marycrest has always been more than just a few buildings on a piece of property. It was so much about the sisters and the people that studied and worked there. And I believe somehow the sisters put their hearts and souls in these beautiful old buildings, along with the brick and mortar. The grounds and the buildings have been beautifully restored, and even more important, the spirit of Marycrest lives on. Our residents love the campus and their apartments; they have made friends with one another and enjoy doing many activities together. The people that work at Marycrest care about their residents and work hard at making them feel comfortable and at home. They put forth that extra energy, just like the CHMs and our faculty and staff. The residents enjoy our staff, and feel lucky to be on campus.

We play croquet on the quad, we take walks on campus and talk about the history of the school. We talk about who planted what tree for what reason! We had a Beach Party to celebrate the coming of warm weather. There was an outdoor concert on the quad this summer. Several "Marycresters" have volunteered for activities in my building. The campus is alive and well. So I'm hoping you can be happy with what Marycrest has become. We have sadly lost our school. But, part of the mission of the school was to meet the needs of the time. The campus is being used for that - meeting the needs of our time.

I once read in a 1945 Marycrest Quarterly, "May blessings rest on Marycrest hill, encompassing it ever with the good, the true and the beautiful." I think we should celebrate, knowing that the campus is blessed with new residents on the hill who truly want to be there.
